### Victory Series Rules

It is your responsibility to know all rules.

- 1.) Victory Series events are not U.S. Angler's Choice events. These events are owned and operated by other individuals and, or organizations. You will be fishing under their "event rules and policies." you must enter these events to enter the Victory Series.
- 2.) Only U.S. Angler's Choice members can participate in Victory Series events. We are promoting the selected events to our new and existing members.
- 3.) Victory Series payback is a standard U.S. Angler's Choice payback with no Big Bass. Only places will be paid. The money normally designated for big bass will be evenly divided across places.
- 4.) There may be unique rules for some events. If so they will be listed beneath the schedule on each webpage.
- 5.) If an event is cancelled or rescheduled your entry will be refunded or forwarded to the rescheduled event at teams preference. If no fish are weighed within the Victory Series event field, entries will be refunded.
- 6.) If event results become unavailable, lost or otherwise, you will receive a refund. Remember these are not AC events and we have no control over event data.
- 7.) Victory Series entries must be received prior to event launch via mail or online registration.
- 8.) All U.S. Angler's Choice qualification and partner rules apply if there are 7 events listed on the Victory Series schedule. Schedules that list less than 7 events only award "Choice Points" also known as open points. These schedules with less than 7 events listed must have 15 boats to qualify as an event counted towards "Choice Championship" also known as Choice Division winners.
- 9.) Ties will be broken by first entry received.
- 10.) All payouts will be issued by check via mail. Events with more than 20 Victory Series entries will award plaques to first place via mail.
